




Question: Which of the following do you use regularly? (n=103))




Question: How vacant is the block where you currently live? (n=99)




Question: Do people ask you for voting advice? (n=101)




Question: In the past have you voted the straight party ticket? (n=101)




Question: What drew you to this event? (n=104)




Question: Where are you currently registered to vote? (n=106)



Question: In the past, have you vote the straight party ticket? (n=104)




Question: T/F - Michigan voters can no longer vote the straight party ticket. (n=94)




